# Texas Speaks Volumes Voting Rights = Women's Rights

f you're thinking of sitting out this election, DON'T. Remember town, village and county elected officials often go on to become state and federal ones. If you don't like them on a local level, you'll probably hate them on a state or federal level. By then it may be too late. They will be making decisions about guns, healthcare, taxes—and abortion and voting rights!

While eyes are focused on Washington DC, states are stealing people's rights away. The same states passing voter suppression legislation are the ones passing abortion bans.

After a year of historic expansion of voter access and turnout, 28 states have filed more than 106 bills to roll back voter access and 19 states have enacted 33 laws. Since January 2021, 47 states have introduced 561 abortion restrictions, including 165 abortion bans. 106 of those restrictions have been enacted across 19 states, including 12 bans.

If you can't vote, you can't fight back. Right now, this is not happening in New York, but it could.

New York State is rife with examples of migration to higher office. There are many great stories like the present Westchester Assembly delegation, all of whom held local office before being elected to the State; both our pro-choice NYS Senate Majority Leader and County Executive served on the Westchester County Board of Legislators before being elected to higher office.

And then there are many bad stories—anti-choice George Pataki who first served as mayor of Peekskill before going on to serve in the NYS Assembly and Senate, and then as governor where he vetoed access to emergency contraception; or anti-reproductive rights Trump zealot Sue Serino who was elected to the Hyde Park Town Board then Dutchess County Board and now the NYS Senate, voting against every reproductive rights bill to come to the floor; and then there is Trump extremist, right-to-life favorite Rob Astorino who was elected to the Mt. Pleasant School Board, followed by Mt. Pleasant Town Board

# **Countywide Government**

# **County Legislator Races**

The County Board of Legislators consists of 17 seats, all of which are up for election this year. Seven of the 17 are contested races, one of which is an open seat, with no incumbent running for re-election. In addition, pro-choice candidates Smith, Gashi and Walter are running for re-election for the first time and, therefore, are more vulnerable.

### A Critical Race & Open Seat

**Erika Lang Pierce** (CLD 2) is an outspoken advocate for reproductive justice. She has an impressive depth of knowledge derived from her broad range of professional experiences, including Legislative Aide, teacher, and Financial Manager and Director of Technology for a multi-million-dollar firm. Her opponent is anti-choice and does not understand the complexity of issues facing Westchester's women and families. **Elect Erika Lang Pierce!** 

## **Four Targeted Seats**

**Colin Smith** (CLD 1) is an attorney, and former Peekskill Town Councilman and Peekskill School Board member, with an impressive commitment to the Westchester community. Smith is 100% pro-choice. His opponent is anti-reproductive rights and has aligned himself with anti-choice extremists promoting the Trump agenda. **VOTE for Colin Smith!** 

Vedat Gashi (CLD 4), an attorney, supports comprehensive reproductive healthcare. He knows how important it is to

# 2021 PROChOICE Voting Guide WCLA PAC

Our endorsed candidates are highlighted in blue boxes. Help keep abortion legal and accessible.

Vote for endorsed candidates.

Remember: In an odd-year election cycle like this, it all comes down to voter turn out—and the ProChoice Voting Guide is key to turning out our pro-choice voters!

#### WCLA PAC Endorsement Policy, 2021

WCLA PAC makes its endorsements based on the candidate ratings made by the Board of Directors of WCLA – Choice Matters.

WCLA PAC's endorsements are determined case by case. To be considered for endorsement, candidates must complete and return the Organization's questionnaire and participate in an interview if requested. Candidates who fail to return the questionnaire or attend an interview are rated anti-choice and have been fully informed of that consequence before making their decision. All endorsements are made on a strictly non-partisan basis. The questionnaires, incumbents' and opponents' records, leadership, and helpfulness during the legislative session are all reviewed. Consistency between candidates' actions, interviews and questionnaire responses is important. Each race is voted separately. Incumbents may be endorsed over pro-choice challengers if they have consistent voting records and have established a reputation for strong leadership and extra effort in advancing access to abortion and contraception. Non-incumbents may be endorsed if they have demonstrated leadership on the issue. Endorsement is considered only for those who unequivocally support:

- Access to abortion and contraception for all women, unimpeded by laws, restrictions, or regulations.
- Strict confidentiality for all reproductive health care;
- Coverage by public and private insurance of abortion and contraception.

Judicial candidates: To be eligible for endorsement, judicial candidates must participate in an interview if requested.

WCLA – Choice Matters and WCLA PAC are non-partisan and are not allied with any political party. The Organizations' sole mission is to fight for comprehensive reproductive healthcare for all women and to eliminate all inequities in accessing that care. The Organizations hold all candidates to the same standards and do not give any individual special treatment. Endorsements are made but not necessarily accepted. WCLA – Choice Matters and WCLA PAC have never and will never let their judgement and political opinions be compromised on any basis.
